

A Note from the Pastor

Perhaps you remember your first Christmas Eve candlelight service. You'll recall the lights being dimmed in the sanctuary, symbolizing the darkness we brush up against as part of our human experience. Then, the Christ Candle is lit as the first chapter of John is read and we proclaim together that "The light shines in the darkness, and the

darkness did not overtake it" (John 1:5).

And you'll recall that holy moment as the flame from the Christ Candle is shared down the aisles of the congregation, brightening

the sanctuary as the light spreads throughout the room. And finally, mid-chorus of Silent Night, that light reaches you, and you then share it with your neighbor next to you, bearing witness to the "Son of God, love's pure light."

These last few days of 2022 have me reflecting on this question: how do we continue to keep the light of Christ burning even after the presents have all been opened? After the lights and decorations come down, and the last Christmas carol has been played and sung, what does it mean to keep the light of Christ burning bright?


"You are the light of the world. A city on top of a hill can't be hidden. Neither do people light a lamp and put it under a basket. Instead, they put it on top of a lampstand, and it shines on all who are in the house. In the same way, let your light shine before people, so they can see the good things you do and praise your Father who is in heaven" (Matthew 5:14-16).

The Bible doesn't just tell us that Jesus is the light (John 1), but it also tells us that we as Christ's hands and feet are the light that He has set in this world of darkness. We are given the task of shining bright so that God can be seen, heard, felt, and that God may be praised and glorified even by those who may not know their Creator. What a blessing to be chosen by God to be God's representatives in the world today.





Here are just a few ways we can truly be the light of Christ for others:

## 1. Always be loving towards others!

"I give you a new commandment: Love each other. Just as I have loved you, so you also must love each other. This is how everyone will know that you are my disciples, when you love each other" (John 13:34-35).

#### 2. Do what is good and right, even when it's difficult!

"Who will harm you if you are zealous for good? But happy are you, even if you suffer because of righteousness! Don't be terrified or upset by them. Instead, regard Christ the Lord as holy in your hearts. Whenever anyone asks you to speak of your hope, be ready to defend it" (1 Peter 3:13-15).

## 3. Avoid all forms of evil and live as an example of the light of Christ yourself!

"You were once darkness, but now you are light in the Lord, so live your life as children of light. Light produces fruit that consists of every sort of goodness, justice, and truth. Therefore, test everything to see what's pleasing to the Lord, and don't participate in the unfruitful actions of darkness. Instead, you should reveal the truth about them. It's embarrassing to even talk about what certain persons do in secret" (Ephesians 5:8-12).

These are just a few examples of ways in which we can bring Christ's light in a world filled with challenges. I'm sure you can think of many more yourself. Get creative! Come up with new ways you can be light in the darkness for someone as we enter this new year. I look forward to hearing your experiences.

To live in the light is to center our lives wholly around its only true source: Jesus Christ. Jesus powerfully declares in John 8:12, "I am the light of the world. Whoever follows me won't walk in darkness but will have the light of life." As those committed to following Jesus, we are constantly being led by him into the light. He's always shepherding us through the darkest valleys of this world and calling us to a life centered around him and his kingdom.

Turn your gaze fully toward Jesus this new year. Center your life around his love. Open your ears and heart to our amazing and good God who would lay down his life to save yours. Follow Christ in full faith wherever the Spirit guides you and God will lead you into a more abundant life, full of those things we've been talking about over the course of the Advent and Christmas season: Hope, Peace, Joy, and Love!

Debbie, to the event.





If you watch any shows on Public Broadcasting System, I know you've seen their ads for helping fund their programming. Lately, they have one for funds you don't need but must take from your IRA. Could this work for us? And you?? Before he left, Skip Manasco provided the following information from an answer to a question posed by a reader of <a href="www.investmentnews.com">www.investmentnews.com</a> and wanted to share it with the congregation. And of course, it's always best to check with your accountant or financial planner about tax shelter opportunities.

QUESTION: Has my ability to make direct charitable donations from my IRA when I reach the age of 70 1/2 been affected by the new tax law? — Connie Beroza, 69-year-old retiree, Buffalo, N.Y.

**ANSWER:** In short, the strategy of donating to charities directly from an IRA after age 70 1/2 is still around under the new tax laws. The qualified charitable distribution (QCD) has been around for years but was only codified as a permanent law a few years ago. A QCD allows those age 70 1/2 to give money to charities directly from their IRAs in a tax advantageous manner. This allows IRA owners who have attained age 70 1/2 to distribute money directly from the IRA to a qualified charity. Total annual QCDs from all IRAs cannot exceed \$100,000 for an individual. Spouses can each make up to \$100,000 of QCDs.

Making a QCD as opposed to a normal charitable gift has two main advantages. First, a QCD counts toward satisfying the individual's required minimum distribution for that year. Second, the distribution is excluded from the taxpayer's income. It is this second benefit that really shines under the new tax bill. With very few individuals expected to itemize (some estimates say around 5% of filers), the income tax deduction for contributions to charities will be lost for many people. However, if you make a QCD, you get a full exclusion of that income from taxes. So, for any retiree who is 70 1/2 or older, owns an IRA subject to RMDs, and is charitably inclined, a QCD really works out as a way to preserve an income-tax-reducing charitable deduction under the new tax law.
